

Budget Allocation Percentages



Collect Requirements

- Get requirements from the source
 - Scale
 - Integration
 - Life Cycle cost / benefit
 - Understand and manage risks
 - Create test cases as you go
 - Shelf-life of requirements

 - Agile offers inherent cost savings and improved customer satisfaction in software development by getting the end-users involved every inch of the way
 - The issue is not whether to use Agile BUT if we want Agile, how do we implement Agile without disruption?

 According to EVM IT Expert and Author of "Business Agility", Mike Hugos, it is not the process but the way Agile it is implemented that is most critical.



Apply Right Sourcing

According to a recent Diamond Cluster International Global IT Outsourcing Study:

- Number of buyers satisfied with their offshore providers has recently plummeted by nearly 20%.
- Number of buyers that have abnormally terminated an offshore outsourcing relationship in the past 12 months has more than doubled from 21% to 51%.
- Number of buyers planning to increase their offshore outsourcing in the next 12 months has declined from 86% to 70%.
